10.1 Motion re: Homelessness to Premier Ford

Resolution No. 2023-46

Moved By: Councillor Groenheide Seconded By: Councillor Jones

WHEREAS the homeless crisis is taking a devastating toll on families and communities, undermining a healthy and prosperous Ontario;

WHEREAS the homelessness crisis is the result of the underinvestment in poor policy choices of successive provincial governments;

WHEREAS homelessness requires a range of housing, social service and health solutions from government;

WHEREAS homelessness is felt most at the local level of government and the residents that they serve;

WHEREAS municipalities and District Social Administration Boards are doing their part, but do not have the resources, capacity or tools to address this complex challenge; and

WHEREAS leadership and urgent action is needed from the provincial government on an emergency basis to develop, resource, and implement a comprehensive plan to prevent, reduce and ultimately end homelessness in Ontario.

THEREFORE be it resolved that the Council for the Township of Gillies calls on the provincial government to urgently:

- i) Acknowledge that homelessness in Ontario is a social, economic, and health crisis;
- ii) Commit to ending homelessness in Ontario;
- iii) Work with AMO and a broad range of community, health, indigenous and economic partners to develop, resource, and implement an action plan to achieve this goal.

AND FURTHER THAT a copy of this motion be sent to the Minister of Municipal Affairs and Housing; the Minister of Children, Community and Social Services; The Minister of Health; and the Association of Municipalities of Ontario. Carried
